

FREEDOM OF INFORMATION STATEMENT

Pursuant to section 9 of the [Freedom of Information Act 1991](#) (the Act), the following statement is made by the Commission on Excellence and Innovation in Health (CEIH).

Subject to certain restrictions to protect legitimate government, public and private interests, the Act gives you a legal right to:

- request access to documents held by a State Government agency
- request the amendment of documents about you which are incomplete, incorrect, out-of-date or misleading
- seek a review of a determination made by a State Government agency

Agency functions and structure

The CEIH is an attached office of the Department of Health and Wellbeing (DHW), providing leadership and advice across SA Health and the State Government on clinical excellence and innovation, to improve the health of all South Australians. The CEIH is made up of the following directorates:

- Office of the Commissioner
- Consumer and Clinical Partnerships
- Clinical Informatics and Innovation
- Human Centred Design and Improvement

The CEIH is also guided by the Clinical Advisory Council and Statewide Clinical Network Steering Committees which provide advice, insight and support on our programs of work, aligned with statewide health priorities.

- increased confidence and pride in the health system

Applying for access to documents

FOI applications for access to CEIH documents must –

- be made **in writing** by **one** of the following methods:
 - completing a State Records SA [Request for Access to Documents](#)
 - completing an online [Freedom of Information Request](#)
 - sending a letter or email to:

- specify that the application is made under the Act
- be accompanied by the prescribed application fee – **currently \$40.75***

- clearly identify the documents being sought
- specify an Australian postal address where information can be sent
- specify how you would like to access the documents – either electronically or hardcopy, or viewed in person

*Additional processing charges may be incurred, however a reduction of fees and charges may apply in certain circumstances.

Review and appeal

If access to all or part of a requested document is denied, you will be informed of the reasons why and advised of your rights to seek a review or appeal.

Internal Review

Applications for an internal review of an FOI determination must be made within 30 days of the date of receipt of the determination. Applications are available from the State Records SA website [Application to Review a Decision under FOI](#) .

External Review

If you are dissatisfied with the internal review, you can lodge a request to the [Ombudsman SA](#) for an external review of determinations:
